

## FEE SCHEDULE & API PAYMENT AUTHORIZATION FOR THE API (<u>"API FEE SCHEDULE"</u>)

This API Fee Schedule is incorporated into the terms of and made part of the zingfit API License & Agreement ("API Agreement"), between Client (e.g., the API User) and zingfit. Capitalized terms not defined herein are defined as set forth in the API Agreement.

Client agrees to pay zingfit all of the fees set forth below in exchange for accessing and/or using the API (collectively, these fees are referred to as the "API Fees") and Client hereby authorizes zingfit to process payment for the API Fees on a monthly basis as set forth below.

## 1. API FEES

- a. "Network Access Fee." Client shall pay zingfit the Network Access Fees as set forth in the Service Tier Add-Ons section of the App Hosting Agreement, which shall be in addition to the other fees set forth herein.
- b. Call Volume Fees.
  - i. Subject to the exception in the following subparagraph, Client shall pay zingfit a Call Volume Fee equal to 1/3 cent (\$0.00333) for each and every API Call.
  - ii. Notwithstanding the proceeding, If Client is using the Independent Developer OAuth App to create a mobile or desktop application for customer bookings, then Client shall pay a Call Volume Fee of 1/3 cent (\$0.00333) on only those API Calls that exceed 2600 calls per Studio during a calendar day – e.g., the 24-hour period beginning at midnight (12:00a.m.) EST and ending at 11:59 PM EST for such day.
  - iii. The Call Volume Fee for each day, if any, shall be rounded to the nearest cent for purposes of determining the total Call Volume Fee payable to zingfit on a monthly basis.
- c. <u>High-Demand Call Volume Fees</u>. In addition to other fees and notwithstanding anything herein to the contrary, if an Client uses any of the Independent Developer, Custom and Reporting OAuth Apps, then Client shall also pay zingfit a "High-Demand Call Volume Fee" of 66 cents (\$0.66) for each API call made by each Studio between the hours or 12:00 PM and 12:15 PM Sundays and Mondays in the local time zone of each Studio.
- d. "<u>Permitted Call Volume</u>." The Permitted Call Volume for Client will be limited for each UAuth App to 100 calls per rolling 15-second interval per Studio.
